

Tuition Information 2011-2012

We have changed and adjusted our methods of tuition billing to reflect the changing needs of our families. We have created a tuition management plan that we hope will fit everyone's budget and lifestyle:

- >>**Plan A** - One payment in full due on or before - September 1, 2011.
- >>**Plan B** - Three equal payments, due on - July 1, and November 1, 2011 and March 1, 2012.
- >>**Plan C** - Ten payments to be paid from - July 1, 2011 through April 1, 2012.
- * **Fee for Books and Supplies** \$250.00 (non-refundable/non-transferable)
- * *This fee for each child is separate from tuition.*

If you choose Plan C, the payments will be the same each month *if* your payment is received by the date stated on your bill. We do not charge a late fee.

Please Note:

The first bill for all payment plans is sent in mid June. You will be billed according to the payment plan you have chosen. The bills are sent to you by mail approximately 10 days prior to the due date. The date that your bill will be mailed is posted in the Monthly Newsletter that the children bring home on the first of each month.

Scholarships:

St. Theresa School receives a small amount of scholarship money from the Catholic Schools Foundation to be distributed among qualified families of Kindergarten II – Grade 8 students. Families may apply online after the New Year at www.factstuitionaid.com or complete the application sent home from school in early March. Families are responsible for applying each year by the deadline, and returning the application and required paperwork by computer or mail to FACTS which is an independent company. The application fee is \$25. Families who qualify for a scholarship will be notified by St. Theresa School during the summer.

Non-Payment Policy:

If you do not make tuition payments according to the tuition plan you have selected, you will be required to pay in full. *As stated in our Calendar/Policy handbook, your child may not begin classes in September or may be suspended from classes if tuition is not current.* If we receive checks that do not clear the bank, you will be required to pay by bank check, cash or money order and you will be charged a bank fee in the amount of \$10 for each check returned.

Re-Registration:

We re-register all currently enrolled students for the next school year during the following times:

ECP, KI and KII are re-registered by January 31, 2012

Grades 1 – 7 are re-registered by May 1, 2012

A re-registration application form is sent home with each child prior to the due dates. To reserve placement for your child, return the application form with the re-registration fee and the fee for books and supplies.
